## NEW JERSEY HIGHLANDS WATER PROTECTION AND PLANNING COUNCIL CONTRACT WITH RUTGERS UNIVERSITY'S VOORHEES TRANSPORTATION CENTER

WHEREAS, the Highlands Water Protection and Planning Act (Highlands Act) has created a public body corporate and politic with corporate succession known as the Highlands Water Protection and Planning Council (Highlands Council); and

WHEREAS, Section 6.g. of the Highlands Act authorizes the Highlands Council to enter into any and all agreements or contracts, execute any and all instruments to carry out any power, duty or responsibility under the Highlands Act; and

WHEREAS, Section 11.a(5) of the Highlands Act requires that the Highlands Council prepare a transportation component as part of the Regional Master Plan; and

WHEREAS, the Highlands Council has prepared a comprehensive transportation program as part of the Regional Master Plan which serves multiple purposes, including identifying roadway capacity constraints, addressing safety concerns, assessing agricultural and freight needs, promoting efficient land use patterns that look comprehensively at land use and transportation planning, and seeking to enhance a multi-modal transportation system which facilitates the movement of people and goods without adversely affecting ecosystem integrity and community character.; and

WHEREAS, to aid in implementing the transportation program, it is necessary that the Highlands Council examine that effects of growth on transportation needs and investment, and to understand and prioritize ongoing and proposed State transportation projects that will impact the Highlands Region; and

WHEREAS, to address the above needs, the Highlands Council seeks to contract with the Alan M. Voorhees Transportation Center (VTC) at Rutgers University, a State agency to undertake these analyses; and

WHEREAS, VTC has considerable experience analyzing the transportation effects of planning policies and development; and

**WHEREAS,** VTC has prepared a scope of work to undertake the transportation analyses for \$50,000.00;

WHEREAS, the Highlands Council staff has reviewed the scope of work submitted by the VTC and recommends that the Highlands Council enter into a contract with VTC.

**NOW THEREFORE, BE IT RESOLVED** by the Highlands Council that the Executive Director, or her designee, is hereby authorized to enter into a contract with VTC for an amount not to exceed \$50,000.00.
