WHEREAS, Section 6.a of the Highlands Act authorizes the Highlands Council to adopt and from time to time amend and repeal suitable bylaws for the management of its affairs; and

WHEREAS, Section 6.g of the Highlands Act authorizes the Highlands Council to conduct its business as needed to effectuate the purposes of the enabling legislation; and

WHEREAS, the Highlands Council has adopted bylaws which provides for Officers of the Highlands Council to more efficiently conduct its business; and

WHEREAS, the Highlands Council on September 6, 2007, through the adoption of Resolution 2007-20, elected William Cogger as Treasurer of the Highlands Council; and

WHEREAS, due to the appointment of a new member of the Highlands Council to replace William Cogger, there is a need to elect a Treasurer of the Highlands Council; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 13:20-5.j, no action authorized by the Highlands Council shall have force or effect until ten (10) days, Saturdays, Sundays and public holidays excepted, after a copy of the minutes of the meeting of the Council has been delivered to the Governor for review, unless prior to expiration of the review period the Governor shall approve same, in which case the action shall become effective upon such approval.

NOW, THEREFORE, BE IT RESOLVED, the Highlands Council hereby elects Robert F. Holtaway as Treasurer of the Highlands Council.
